### **ARW Goals and Outcomes**

#### Goals

- (1) to synthesize expert knowledge on topics of environmental health and security in Ukrainian conflict zones from key academic leaders and policymakers in NATO member and partner countries.
- (2) to develop a research agenda to identify the research questions that can inform policy and help safeguard human health and ecosystem integrity for current and future generations in Ukraine and surrounding regions.

#### <u>Outcomes</u>

- (1) to produce a NATO science series publication (Springer Verlag) on environmental health and security that summarizes the findings and policy recommendations of the workshop and guides future research investigations in the region.
- (2) to build strategic partnerships in Ukraine and neighboring countries with opportunities for exchange of ideas, networking, and research infrastructure.

### Security Relevance and Impact

Geographically and politically, the ongoing conflict in Ukraine is a lynchpin for Euro-Asia affairs and stability. Without a secure Ukraine, the surrounding NATO member and partner countries are also vulnerable to conflict and environmental insecurity. This workshop will enhance the cooperation and dialogue with participatory NATO countries, focusing on scientific research, innovation, and knowledge exchange on environmental health and security arising from the Ukrainian conflict.
